#### **Update from the HAMAC Chair**

The HAMAC Chair provided an update on the VCH Medical Staff Rules. This included moving to an iterative process for updating the rules on a more regular basis to ensure the rules are aligning with care delivery, learnings from other Health Authorities, establishment of a governance committee, and ensuring a clear process for future rules updates.

#### **Update from VP Medicine**

The VP Medicine provided an update on the work ahead for the medical leadership structure realignment project. The presentation included a description of how this work will bring us into alignment with the VCH Medical Staff Bylaws, a reiteration of the impetus for realignment, an update on Board direction, and a preview of work in progress to define "standard work" and governance/reporting structures for medical leaders.

#### **HAMAC Priorities**

# **Update on the Morbidity & Mortality Working Group**

Coming out of the June 2024 HAMAC Quality Subcommittee, HAMAC struck a working group to look at standardization of morbidity & mortality rounds at VCH. To date, the working group has completed an environmental scan of best practices, engaged Island Health on lessons learned from implementation of their M&M process, engaged PHC to align standardization work across VCH/PHC, and is currently drafting a Terms of Reference for local level M&M Committees.
