## Indigenous cultural safety corner

On May 5<sup>th</sup>, HAMAC marked Red Dress Day, a national day of remembrance and awareness for Missing and Murdered Indigenous Women, Girls and Two-Spirit People. The red dress has become a powerful symbol of the lives stolen and those who continue to call for justice.

HAMAC is committed to addressing the findings of "Reclaiming Power and Place: The Final Report of the National Inquiry into Missing and Murdered Indigenous Women and Girls" and the "In Plain Sight: Addressing Indigenous-specific Racism and Discrimination in B.C. Health Care" reports. These reports highlight that, as caregivers and matriarchs, Indigenous women play a central role in community wellness and frequently interact with the health-care system, yet they face distinct challenges and have disproportionately poorer health outcomes.

This day compels us as healthcare leaders to confront the disproportionate harms Indigenous women and gender-diverse people continue to face. It challenges us to address the systemic racism and gendered violence that persists in our systems, including within health care.

## **Planetary Health Update**

HAMAC received a presentation from Dr. Rashmi Chadha, Planetary Health Clinician Engagement Lead and Breanna Gregory, Leader, Planetary Health and Emergency Management. The presentation included an overview of the <u>Planetary Health portfolio</u> and highlighted some recent Planetary Health work at VCH.

The Committee looks forward to hearing further updates from the Planetary Health team on their initiatives.

## **Regional Department Quality/HHR Reports**

#### **Regional Department of Nurse Practitioners**

Dr. Jennifer Buck, Regional Department Head of Nurse Practitioners, presented a report on the department's activities across VCH. The report included an overview of the department's governance structure, workforce composition and practice patterns. Key quality metrics were highlighted, including improvements in length of stay, readmission avoidance and continuity of care. The report also addressed current challenges and opportunities within the department.

#### **Regional Department of Medicine**

Dr. Robert Levy, Regional Department Head of Medicine, presented a report on the VCH/PHC Department of Medicine. The report focused on three ongoing quality improvement initiatives and included a detailed overview of the department's health human resources. Dr. Levy emphasized the challenges and opportunities related to workforce planning and sustainability within the department.

Dr. Mike Norbury has returned to his role as SMD, VC, and Dr. Vandad Yousefi has resumed his position as Local Department Head. We are pleased to welcome Bill Duvall to the role and look forward to working with him to advance our shared commitment to quality care and system excellence.

## **CMIO Update**

HAMAC received an update from Dr. Eric Grafstein, Chief Medical Information Officer, on work in progress on patient access to their health records through the new CST Cerner Patient Portal that is planned to go live in fall 2025.

We are working towards a number of decisions on timing for delays to release of information and a process for exceptions to note distribution.

This topic will be coming to the Area Medical Advisory Committees next month for further discussion.
